Additional fees may apply if the wedding date falls on a holiday. Wedding individuals listed above, must arrive as pre scheduled by salon personal; or incur late appointment charges. Please arrive with clean dry hair to avoid drying time, unless instructed by salon personal to avoid additional preparation charges.

All in salon services will be of a professional nature, performed by Bodyworks Salon & Day Spa licensed salon and spa personal only.

Balance payment is due on wedding day; deposit credited to your account.

Additional GST and 20% gratuity charged on all appointments.

Cancellation Policy -Written notification must be received 60 days prior to wedding date to receive full refund on all appointments or changes in appointments. No phone messages accepted. 30 days prior to wedding date deposit will be forfeited. After 30 days or if no notification is received full listed appointments payment amount is required.

Any additional appointments required on the day of the wedding or after this signed agreement will try to be accommodated.
